Our History and Mission

"To advocate for and provide the resources, skills, and shelter to alleviate abuse through prevention and intervention for all children and their families."

Manatee Children's Services was founded in 1977 by Carol Chamberlain: a librarian, teacher, and social worker with a passion for child advocacy. Through her work in social services, Carol learned that Manatee County had a dire need for shelter to house abused children removed from their homes. She rallied a group of citizens to make the shelter a reality and, to this day, MCS continues to operate as Manatee County's only emergency shelter for child victims of abuse and the county's only Child Advocacy Center.

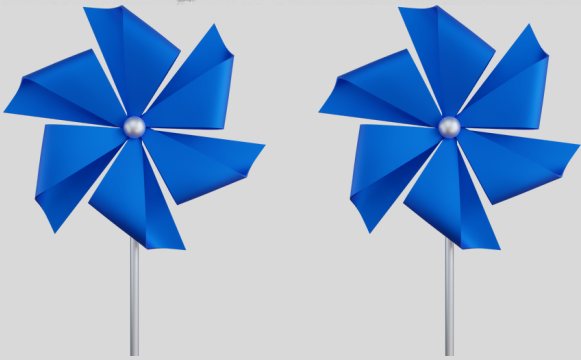
We provide a full spectrum of programs serving over 12,000 children and families annually. We offer programs in treatment, prevention, intervention, and residential services. Such programs include an emergency shelter, long-term group homes, mental health services, parenting education and training, forensic medical and specialized child victim interview services, support services for relative caregivers, teen pregnancy prevention, and children's personal safety. 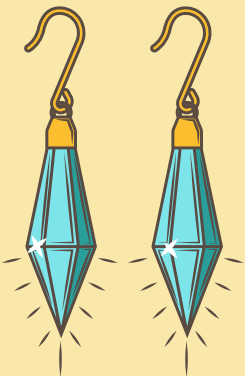

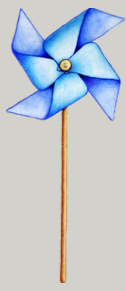
COMMUNITY NEWS

AGENCY NEWS



Thank you to the Manatee Community Foundation and the Wilson-Wood Foundation for their generous grant awards in August.

The MCF Manatee Foster Care Initiative Fund awarded our agency \$5,100 for Hurricane Debby relief. Fortunately, our children, staff, and facilities remained safe and free from storm damage; however, the emergency staffing and supplies necessary for sheltering in place created a financial strain, which MCF's funds greatly helped to alleviate.

The Wilson-Wood Foundation also provided tremendous support with a \$20,000 grant for our clinical "Non-Offending Caregiver" (NOC) program. This funding will cover group therapy sessions for Spanish-speaking caregivers raising children who have experienced sexual abuse. We are so grateful for their second year of funding for NOC. COMMUNITY SPOTLIGHT:

BISHOP-PARKER FOUNDATION



We'd like to honor a very special supporting organization, The Bishop-Parker Foundation, and their new CEO, Wendy Deming. Wendy brings more than 25 years' experience in the independent sector, including Chief of Staff and Chief Operating Officer at Gulf Coast Community Foundation and Marie Selby Botanical Gardens.

"These roles allowed me to manage operations and governance during significant periods of growth" Wendy said. "I am thrilled to join the Foundation as its first full-time CEO and to collaborate with a dedicated Board of Trustees. This role offers me the unique opportunity to honor and advance the legacies of the Bishops and Mary Parker, driving impactful change for our community."

Bishop-Parker enhances Manatee County by providing strategic financial support to nonprofits. Their mission focuses on uplifting individuals and animals, with funding priorities in health, human services, education, the arts, the environment, and animal welfare. The Foundation's origins trace back to John Huntington, an English immigrant whose business success and philanthropy laid the groundwork for their legacy. Huntington, in partnership with John D. Rockefeller, played a key role in revolutionizing the oil industry and contributed to the creation of the Cleveland Museum of Art. His descendants, including Lillian (Patty) H. Huntington and her husband Edward E. (Ned) Bishop, carried on this tradition of giving. The Bishops, who settled in Bradenton in 1914, became significant benefactors in the region and founded the Edward E. and Lillian H. Bishop Foundation in 1953, while their close friend, Mary Parker, established her own charitable foundation in 1986. Parker's legacy of generosity continued until her passing in 2020, leaving a lasting impact.

Bishop-Parker's support for MCS is inspired by Parker's legacy as a dedicated advocate for children's well-being. Wendy stated their Board is committed to continuing her vision, ensuring every child grows up in a safe, nurturing environment.



MCS PROGRAM HIGHLIGHTS



Caregiver support is crucial for a child's recovery from sexual abuse. However, Spanish-speaking families often face barriers in accessing critical education and resources. To address this, the MCS clinical team offers Spanish-Speaking Non-Offending Caregiver (NOC) support groups. These groups, held 3-4 times annually for 8 weeks each, provide a safe space to learn coping skills and share experiences, helping caregivers support their children heal.



“I now don’t feel guilty about what happened to our children because no one knows who we are surrounded by,” NOC participant Jennifer* said. “We don’t know what will happen tomorrow, but we now know what to look for to keep this from happening again to my children.”

“I don’t feel alone anymore because there are people living the same situation as me and we were able to express ourselves with confidentiality,” NOC participant Amy* said.
